In 2009, he was named deputy project construction manager for the \$1billion DFW Connector public-private partnership. In 2011, he was promoted to North Tarrant County area engineer. During that time, he oversaw the \$4billion North Tarrant Express, including the procurement and construction of I-35W, and the successful delivery of the West 7th Street bridge, the world's first pre-cast network bridge. After being selected as the director of maintenance in 2014, he oversaw a \$120million maintenance program and worked to improve the district's four-year pavement management plan. Gonzalez was named transportation planning and development director in 2018.

As director of transportation planning and development, Gonzalez oversees the district's Bridge Design, Bridge Inspection, Central Design, District Design, Public Transportation, Right of Way and Transportation Planning and Development offices.
